Currently, Kate's Kart, Inc. has over 114 volunteers collecting, counting, sorting, labeling, stocking and distributing more than 2,000 books per month to 20 area hospitals and several pediatric offices. During 2020, Kate's Kart distributed 24,659 books to 32 karts in 20 area hospitals.
