A Message from the Director

Oh what a year! Looking back on 2020 brings back so many memories. Memories of sadness and grief over the loss of many things. But at the same time...l saw the resilience of the human spirit and the generosity of our community shine brighter than ever before.

On March 13, I received emails from all the hospitals that our volunteers would no longer be allowed in the hospitals. I thought for sure that phone calls would come soon after... "For safety reasons, please remove your Karts from our emergency rooms and hospitals." But those emails never came. Instead, we heard from each hospital that they were doing all they could to continue delivering our books in a safe manner. They told us the kids NEED those books, now more than ever. Comfort was essential during a time when going to the hospital was even more scary than before. Everyone was hidden behind a mask and smiles couldn't be shared. But the gifting of a new book brought out the twinkle in the eyes of kids and parents. Kate's Kart Books became "essential" during this global pandemic that rocked all of our worlds.

We worked with the hospitals in figuring out ways to continue distribution in Emergency Rooms that now had more restrictions, as well as in the larger hospitals that we usually served through volunteers. We added a few more Karts to make distribution for the staff easier. Kate's Kart continued in all 20 hospitals...kids were still receiving the gift of new books to ease their hospital stay. And over the course of the year, our volunteers slowly returned to sharing the love of reading with kids and their families. We found our new normal and adapted.

At the same time, schools, organizations, and even small businesses closed or slowed down. Normally, our spring is filled with book and fund drives...but that came to a halt. Donations of books and funds were

down significantly. But thanks to the Community Foundation Of Greater Fort Wayne, a special GIVING TUESDAY NOW was held in April and we saw our generous community step up and support us with over \$6,000 in donations that went far in helping us through those first few months of COVID-19.

Fast forward to our summer and our normal fundraiser...an amazing celebration of Kate's Kart and ice cream...and 2,500 people. Our Board worked quickly to redesign our fundraiser to be distanced and safe. And once again, our community stepped up and supported not only Kate's Kart but 12 locally owned ice cream shops. We raised just as much money through sponsors and donations as we have with our normal fundraiser...Generosity at its best.

And it didn't stop...our Giving Tuesday campaign in early December continued to see the outpouring of support...once again easily surpassing our goal and reaching our match from McMahon Best One Tire.

Throughout the entire year, we continued to see generosity overflow through donations of funds and books to support our mission. In a year that took away so much, Kate's Kart was given so much. And although the financial support was essential to us continuing our mission, one thing meant the world to us. Kate's Kart placed 2nd in the Favorite Charity category in the Fort Wayne Newspapers Best of Fort Wayne. What we do matters and our community saw that and responded. Our hearts were humbled.

Every single book we gift has the potential to make a significant impact on a hospitalized family. Every book can create a memory that will last a lifetime...far surpassing the memories of 2020. Books just have that potential...and for the ability to gift over 24,000 new books in 2020 is a complete honor. THANK YOU for believing in us and our mission.







2014-present, in addition to distribution above, includes time spent in meetings and planning done by the Board of Directors and planning committees.


*2012: Decrease due to closing of Parkview Randalia pediatric floors.

*2017: Decrease due to hiring of part-time Administrative Assistant.


*2018: Decrease due to hospital restrictions due to flu season.



2020 Ice Cream Social...Distance Recap

In a year of the pandemic, our team was able to creatively offer an event unlike ones we have done in the past. By partnering with local ice cream shops we were able to create an event that received visibility from most counties where we have a presence. This event not only provided us with as much funding as our normal Ice Cream Social Event, but also allowed us to reach audiences in other counties across Northern Indiana.

Our 2020 Ice Cream Social...Distance was a huge success.

We are so grateful to everyone who pulled together and allowed our major fundraiser of the year to be just as successful as in the past. We certainly missed gathering together at the park, but the smiles we saw on so many faces as they indulged in ice cream made up for our disappointment.

- 1. We partnered with 12 local ice cream shops. We estimate thousands came out for ice cream all over Northeast Indiana in celebration of Kate's Kart. All of you generously donated in our boxes on-site and many of the shops donated proceeds as well, allowing us to raise over \$8,000 that day.
- 2. Our amazing team of sponsors continued to give, even though our event looked different. In total, 38 companies donated \$32,000...funds that went directly to our operating expenses.
- 3. Together with our sponsors, t-shirt sales and donations, we were able to raise over \$47,000. We are grateful for your support.
- 4. Along with our sponsors and Prairie Farms Ice Cream, we delivered over 1,400 individually wrapped ice cream treats to all 20 hospitals we serve. Our hope was that the Emergency Room and Pediatric staff were encouraged by this little treat. We are so grateful for their continued partnership and helping us to distribute the books, especially when our volunteers weren't in the hospitals.

Due to continued safety issues with COVID-19 and large gatherings, Kate's Kart Board of Directors has made the decision to host our 2021 fundraiser in a similar fashion to 2020. We will once again be partnering with local ice cream shops and hosting a Go Eat Ice Cream Day on June 26. We plan to have giveaways and small games at each location. Halsey's Story

"I remember escaping from a harsh reality into the fantastical worlds of books delivered by volunteers from a local organization called Kate's Kart. I eagerly waited for the smiling volunteers to appear with a new selection which was frequently the highlight of my week.

The stories were often chosen and read by my grandmother. My imagination brought them to life as a way to shelter my mind from what was actually happening.

An enchanted forest sprang up around me. An ugly old witch sat in a hollow tree, futilely chewing on the knots of her cursed rope. Mermaids stared up at me from beneath the



surface of a lake. Fairies with butterfly wings danced before my eyes. I saw all of it almost as if it were real, but my reality consisted of five surgeries and a newly acquired feeding tube and tracheostomy."

This is an excerpt from a story I recently wrote for my SMA News Today column, From Where I Sit. In it, I chose to highlight some of my memories from a hospitalization in Lutheran Hospital's PICU ten years ago. Deciding which ones to share was a challenge, but there was one story that stood out in my mind from the moment I decided to write that piece. No matter what else I ended up putting into that column, I knew beyond a shadow of a doubt that Kate's Kart was going to be a part of it.

I've been a self-proclaimed bookworm for as long as I can remember. I was the kid that carried a book with me everywhere and came home from the library with stacks of new reading material. As an adult, not much has changed. I have a fully stocked Kindle library that I carry with me, and it's nothing short of a miracle if I leave a bookstore without buying something.

Books are such powerful objects. They can teach us something new, transport us to a different world, speak to our souls, and so much more. And for the hospitalized children that Kate's Kart serves, books provide comfort.

The impact of a good book can last for many years. The impact of kindness and compassion can last just as long, if not longer. Kate's Kart gives all of these things to children and their families throughout our community. The people who have received a book from this wonderful organization have not forgotten that comforting experience. At least, I certainly haven't. - Halsey Blocher
